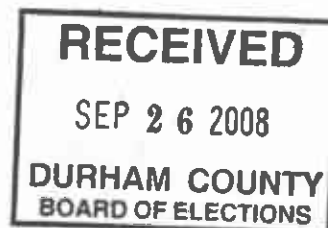

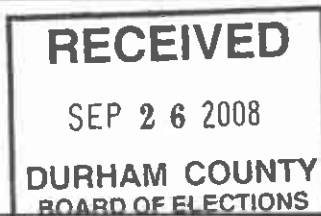

Final Statement for Accounts of Committee to Elect Kirsten Kainz—September 25, 2008

When the Committee went into dormancy, we had a bank account balance of \$171.97.

This was a business checking account at BB&T. In June 2007, the bank began charging a \$5/month inactivity fee. I discovered this in July 2007 after \$10 had been debited. Talking with a bank officer, I learned that the only way to avoid this fee was to register some activity every few months. She told me any activity would suffice so I deposited \$10 to cover the fees. We were then charged another \$5 fee and I learned that a withdrawal, not deposit, had to be made to qualify as activity.

I then wrote our last check to James Kainz, the candidate's husband, so close account, thinking they could either "hold" the sum in their personal account until Kirsten ran again, or she could open a personal, not business, account for Committee. They were not comfortable with this plan; so for the next several months, I deposited and withdrew sums of \$5 or \$10 dollars every few months to prevent further fees.

On March 15, 2008, Kirsten called and said she was seeing Leigh Bordley, a School Board candidate, that day and wanted to donate the Committee's balance to Leigh's Committee. I said I could find no more checks, but she should give Leigh the amount of our remaining balance; and I would work on closing the account to reimburse that donation as our Committee was allowed to donate to another Candidate's committee.

When I went to close account, by withdrawing remaining funds at BB&T, I found that I could only withdraw the funds by writing a check. I had written our last check to J. Kainz (which I had since they had not taken it) and wanted to avoid having to spend campaign funds on more checks. I then realized we could use the check written the previous year, by changing the year (and initializing). This is what we did.

The check to James Kainz of \$161.79 was deposited to close out the Committee Account and the remaining \$10 reimbursed me for the \$10 I had been depositing and withdrawing to keep account active.
